As per the information furnished to me by the Company and after the scrutiny of remote evoting result, I submit hereunder:

The Company has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on Friday, January 27, 2023 ("the cut-off date"), the Company completed dispatch of the Notice of Postal Ballot on Thursday, February 02, 2023 by E-Mail to the Members who had registered their emailids with the Company/ Depositories. The postal ballot notice was also made available on the Company's website at https://www.allsectech.com.
- The Public Advertisement with respect to dispatch of postal ballot was published on Friday, February 3, 2023 in English Newspaper "Financial Express" & in Tamil Newspaper "Malai Malar"
- In terms of the aforesaid notice, Members were required to convey their assent or dissent, through remote e-voting system, on e-voting platform provided by Kfin Technologies Private Limited (Kfin) from 07<sup>th</sup> February 2023, Tuesday, at 9:00 A.M. (IST) to 8<sup>th</sup>March 2023, Wednesday, at 05:00 P.M.(IST).
- 4. 28 Ballots were received on the remote e-voting platform till 5:00 p.m, (IST) on 8<sup>th</sup> March 2023, Wednesday.
- 5. After the scrutiny of the remote e-voting result, we report that the Ordinary Resolution as contained in the Notice of Postal Ballot dated January 24, 2023 has been passed with requisite majority.
